CALL TO ORDER:

Mayor Karl Curtis called the meeting to order at 7:00pm.

APPROVAL OF AGENDA:

PRESENTATIONS:

a. Fire Chief Update

The department attended 5 motor vehicle accidents, 1 motor vehicle on fire, 2 mutual aid structure fires, 1 structure fire, 1 large tree on road, and 1 alarm call since the last Regular Council Meeting. The department continued its bi-weekly training and is completing a slope/rescue exercise at dusk tonight.

b. John Moulton, Shogomoc Railway Site

John Moulton did a presentation on why he feels the Town needs to open the Shogomoc Railway Museum again with a full-time curator, along with his desire to operate a restaurant in the first railcar if the museum were operational.

c. Florenceville Kin Club, Jody Foster

Jody Foster gave Council some information about their upcoming Annual District 7 Atlantic Fall Leadership Council meeting with approximately 100 delegates, which is being held in Florenceville-Bristol this year at the Amsterdam Inn. They are looking for some projects to do in Town as part of the event on Friday, October 29. Jody asked for the Town to have the Kin banners flying throughout the event. The Mayor said he was looking forward to attending the banquet.

a. Municipal Reform

- CAO and staff continued to meet with the Transition Facilitator to draft a combined 2022 budget, and are now working on the 2023 budget.
- A software program is being developed by the province that will be made available on the Elections NB website at https://www.electionsnb.ca so residents can type in their address to find out their ward. Maps are also being worked on by the province.

b. Regional Service Commission (RSC) Reform

- The RSC has drafted their 2023 budget.
- The 2023 budget increased \$1.6 million from \$3.1 million to \$4.7 million, which includes the new mandated services.

NEW BUSINESS:

a. Planning & Development Grant, Florenceville Ag

Council reviewed an application received from Florenceville Ag. The grant pays 85% of the approved grant when the project is 50% complete, and pays the balance based on the actual property assessment increase after completion.

MOTION: To approve a \$32,000 Planning & Development Grant for Florenceville Ag Ltd. Moved by Councillor Dan Guest, seconded by Councillor David Trafford.

b. Sponsorship Grant

Council had approved a Sponsorship Grant for McKencroft Productions to apply to CNCF for \$8,000 at the June meeting. That application was approved for \$4,000, so they still have a shortfall in addition to an anticipated 6% cost overrun. Therefore, they would like to apply for Community Involvement Funding (CIF) through the Province for \$5,000 and are asking Council to sponsor their application. Council would not be directly contributing financially to McKencroft, but the Town would be applying directly for CIF on McKencroft's behalf and transferring any approved funds to them accordingly.

MOTION: To sponsor McKencroft Productions' application to the provincial Community Involvement Funding for \$5,000. Moved by Deputy Mayor Nancy Whyte-McCauley, seconded by Councillor Dan Guest.

c. Street Sign Request
